AN ORDINANCE AMENDING ORDINANCE NO. 1537
PERTAINING TO THE COMPOSITION OF THE CITY'S
GATEWAY 7 ADVISORY BOARD, PROVIDING FOR THE
ADVISORY BOARD MEMBERS TO ELECT A NON-VOTING
CHAIRMAN OF THE BOARD WHO WILL NOT BE A MEMBER
OF THE BOARD FOR COUNTING QUORUM OR FOR ANY
OTHER PURPOSE; PROVIDING THAT SUCH CHAIR SHALL
SERVE AT THE PLEASURE OF THE ADVISORY BOARD,
THE BOARD OF DIRECTORS OF GATEWAY 7 DEVELOPMENT DISTRICT, AND THE CITY OF PLANTATION,
PROVIDING THAT SUCH CHAIRMAN BE CONSIDERED AN
OFFICIAL FOR THE PURPOSE OF CITY INDEMNIFICATION; PROVIDING A SAVINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE THEREFOR.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PLANTATION, FLORIDA; that:

Section 1: Section 6 of the City of Plantation Ordinance No. 1537 is hereby amended to read as follows:

Section 6 Establishment of Advisory Board. An Advisory Board is hereby established for the Local Government Neighborhood Improvement District created hereby. The Advisory Board shall be composed of no fewer than seven members who shall be owners of real property located in the District or residents of the District. The members of the Advisory Board shall be appointed by the Board of Directors and serve at the pleasure of the Board of Directors. The Advisory Board may be able to elect a non-member Chairperson (who, once approved by the City as hereafter set forth, will not be a member of the Board for counting a quorum or for any other purpose and who may not vote on matters coming before the Board). The non-member Chairperson selected shall be a City resident and shall be familiar with the special needs and unique circumstances of the A non-member Advisory Board District. Chairperson-elect shall not commence service to the Advisory Board unless and until he or she is approved by the City governing body. Once approved by the City governing body, such non-member Chairperson of the Gateway 7 Advisory Board shall be considered an "official" within the meaning of 2-106 City Code for purpose of the indemnification set forth in DIv. 2 of Chapter 2 of the Code of Ordinances of the City of Plantation. The non-member Chairperson shall serve at the pleasure of the Board, the Board of Directors of the District, If the Advisory Board wishes, it may elect one of its own Board members as its Chairperson, which member Chairperson may immediately commence service to the Board without prior District or City approval, may vote, and may exercise all other privileges of a Board member.) the Advisory Board shall perform such duties as may be prescribed by the Board of Directors and shall submit within the time period specified by the Board of Directors, a report on the District's proposed activities and a proposed budget to accomplish the District's objectives. In formulating a plan for services or improvements, The Advisory Board shall consult in public session with the appropriate staff or consultants of the City of Plantation responsible for preparation of the District's plan.

Section 2: Should any clause, section or other part of this Ordinance be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

Section 3. This Ordinance shall become effective immediately upon passage on second reading and signature by the mayor.
