On-Line Web User Declaration Form

The City of Plantation, Building Department requires that the licensed qualifier read the following legal declarations. The qualifier will need to sign below and have signature notarized. The original declaration form must be returned to the Building Department in person, by mail, fax or email.

Terms & Conditions:

All On-Line Web/Digital Plan Permits are subject to review and approval by the City of Plantation Building Department.

All work authorized by an On-Line Web/Digital Plan Permit must comply with all applicable ordinances, statutes, rules and regulations or codes adopted by the City and the State.

All work authorized by a permit is subject to inspection. Required inspections can be obtained online or by calling the inspection line at (954) 678-2632. Access to the jobsite/property must be provided for inspection purposes.

Permits shall automatically **EXPIRE** and become **null and void** if work is not commenced within 180 days from the date permit was issued, or if such work is suspended or abandoned for a period of 90 days, or an approved inspection is not obtained within 90 days, in accordance with the Florida Building Code in effect at time of application.

Any false information provided during the permit application process will result in a revocation of the permit. This information includes, but is not limited to, contract valuation, work description, licensing information, general liability and worker's compensation.

For all contractors, a current copy of your general liability insurance, workers compensation insurance/exemption and applicable license(s) must be on file in the office prior to applying for a permit via this system. By applying for any permit, I hereby affirm that at the time of making any application for building permit and until Final Completion and (if applicable) final inspection of work for which a permit is issued, the insurance documents provided to the City will be correct and current.

Prohibitions:

Attempts to upload information or change information on this on-line form are strictly prohibited. This prohibition does not apply to a user's submission of information requested via this on-line form created by the City of Plantation.

The City prohibits the use of the seal of the City of Plantation in connection with any merchandise, impersonation, solicitation, or commercial activity in a manner reasonably calculated to convey the impression that such use is approved, endorsed, or authorized by the City of Plantation.
