A RESOLUTION OF THE CITY OF PLANTATION, FLORIDA, DESIGNATING CITY COUNCIL MEETINGS TO BE HELD IN CITY COUNCIL CHAMBERS AT PLANTATION CITY HALL AT 6:00 P.M., EST; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 2.07(a) of the City of Plantation Charter provides: “ The City Council shall meet regularly at least once every month at such times and places as the City Council may prescribe by resolution.”

Section 3. City Council Meetings may be rescheduled or relocated for good cause at the discretion of City Administration, with reasonable advance notice to the public and Councilmembers.

Section 4. All Resolutions or parts of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

Section 5. If any section, sentence, clause or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Resolution.

Section 6. This Resolution shall become effective immediately upon its passage and adoption and signature by the Mayor.
