

### It's Doggie-Palooza Time!!

The City of Plantation Parks and Recreation Department is planning our annual Dog Expo, **Doggie-Palooza**, which will be held on Saturday, January 25th, from 10:00 a.m. until 3:00 p.m. This event will be at Happy Tails Dog Park, Seminole Park, 6600 SW 16<sup>th</sup> Street, Plantation. Past Doggie-Palooza events have been very successful, drawing crowds of over 2,000 people. We are hopeful that this year's Expo will exceed that achievement.

Doggie-Palooza is designed to provide canine owners with information on local companies' products and services. Admission for canines is free. Their human companions cost a \$2.00 per person entry fee to benefit a local non-profit rescue organization.

We are looking for local vendors and groups interested in participating in this event. Participating in the Expo is \$75.00 for vendors and \$35 for non-profit organizations. All participants will be given one six-foot table and two chairs. You must skirt your own table. Once payment is made, there will be no refunds. This event is held "rain or shine."

### City of Plantation, Florida Vendor Waiver and Release

#### Please read carefully before signing.

- 2. In consideration of being permitted to participate in the Event, I agree to the terms of this Waiver and Release.
- 3. My participation in the Event is voluntary. I know and am aware of all the dangers associated with my participation in this Event. I freely, voluntarily, and with such knowledge assume any and all risks, whether known or unknown.
- 4. I understand and agree to release, waive, and discharge the City and its agents, employees, elected and appointed officials, promoters, sponsors, advertisers, sales persons, photographers, and volunteers (hereinafter called "Releasees") from any and all liability for personal injury, property

damages, property theft or any other claims of any kind which relate to or arise in whole or in part from the Releasee's negligence or in any way relate to my participation in this Event. I agree not to sue the Releasees.

- 5. I agree not to sue the Releasees. I further agree to defend, indemnify, and hold harmless the Releasees from any and all claims, costs, expenses, damages and liabilities, including attorney's fees that the Releasees may incur as a result of my participation in the Event or in any way caused in whole or in part by the negligence of the Releasees.

# Vendor Rules & Regulations

Vendor spaces will be assigned by the Parks & Recreation Department. No substitutions.

Each vendor space will be provided one six-foot table and two chairs.

Vendors must provide their own table covering. All tables MUST be covered.

Vendors are responsible for the care and control of their dogs. Dogs must be confined to a well-ventilated dog cage/crate, or on a six-foot leash, and be with a handler at all times. All dogs must have proof of rabies vaccinations on site.

The only animals vendors may bring to the event are dogs. Vendors may provide information about other types of pets for adoption, but this event is open solely to domestic canines.

No chocolate candy at your booth, as it is extremely toxic to dogs.

Food items and beverages cannot be sold or given away by a non-food approved vendor.

The sale, use, or possession of alcohol is not allowed.

Games of Chance are not allowed.

All vendor activity must be confined to the allotted 10'x10' space. Vendors are not allowed in the common areas, including the walkways. Sirens, bullhorns and megaphones are not allowed to draw attention to your booth.

Each vendor is responsible for their booth, which must be staffed at all times.

Rules may be subject to change.

Vendors may begin setting up at 8 am and MUST be completed by 9:30 am.
