CART RELEASE

I will obey the Preserve's Rules. I am responsible for all persons riding in the Cart while it is in my use or possession. I acknowledge that Management may at any time terminate my use of the Golf Cart or the Preserve property. I understand there are inherent risks of golf associated with water hazards, weather, environmental or wildlife exposure, errant balls, golf club use, other golfer acts or omissions (including negligent ones), and Cart use. For myself and for my children or wards, I release and hold harmless the City and its agents from all damages and claims for death or bodily injury, death, and disease including those caused by the above risks, which might be caused by or suffered in connection with the above risks or our use of the Plantation Preserve. I will pay for (and indemnify the City and its agents against) all damage to the Cart, to other property, or to people which is caused by or relates to the use, possession, or operation of the Car by me or by anyone for whom I am responsible. I have a valid driver's license, and I know how to safely operate a Golf Cart.

Code of Conduct

The intention of this document is to establish clear and acceptable behavior expectations for Plantation Preserve Golf Course and Club members and guests. It is not intended to restrict the rights of anyone but rather to ensure that all members and guest can expect to be treated with respect while enjoying the Plantation Preserve Golf Course and clubhouse. The club deems that upon payment of membership or green fees, all members and guests have given their consent to be bound by both the restrictions and penalties imposed by this code of conduct.

All members and guests will:

- Conduct themselves in a sportsmanlike manner and will not knowingly cheat, throw clubs, disrespect employees, officials or fellow competitors
- Respect the rights of other players and golf course staff (Ex: Will not verbally or physically threaten or slander others, either personally or through social media)
- Not engage in any form of sexual, racial religious discrimination or harassment
- Adhere to the dress code and observe proper golf etiquette as well as USGA and local rules of the course. (Ex: following cart signs, or not hitting into the group in front of you)
- Respect the golf course, golf cars and facilities
- Follow sign in procedures in the Golf Shop

- Safely operate carts in designated areas only
- Obey all signage on the golf course
- Take pride in the physical appearance of Plantation Preserve Golf Course and Club as it is reflective of you as a member
- Not conduct themselves in any rude or immoral manner, including the use of profane language, gestures, insults or other such misbehavior.
- Abide by all state and local laws and regulations, including the possession of any illegal drugs and weapons on the property of Plantation Preserve Golf Course and Club
- Represent the Plantation Preserve Golf Course & Club when out in the community or at other clubs.

Resolution of violations to Plantation Preserve Golf Course and Club Code of Conduct

- Should a violation take place, the member will be written up with a warning. If a second infraction occurs, the tee time accessibility will be eliminated for 30 days. A third infraction will result in the suspension of their membership. Lastly, expulsion from the club will happen if behavior still continues.
- In all cases should there be damage to property, monetary restitution will be mandatory to continue membership.

PLANTATION PRESERVE GOLF COURSE & CLUB MEMBER BYLAWS

It is the intent of Club management to establish these rules and regulations for the mutual enjoyment of the Club by all its Members and their guests. The obligation of enforcing these rules for the good of all Members is placed primarily in the hands of a carefully selected and trained staff whose principal responsibility is to assure Members of all customary courtesies, comforts and services. It is further the duty of the membership of the Club to know its rules and to cooperate with management and staff in the enforcement thereof.

Club Management, through the City of Plantation Parks & Recreation Department, retains the right to recommend to City Council from time to time, modifications to these rules, including: periodic increases in fees; availability of facilities to various membership classifications; and all final decisions as to the operation of this facility.

GENERAL RULES & INFORMATION

1. The Plantation Preserve Golf Course & Club and all buildings and other facilities are owned by the City of Plantation, regardless of the funds paid by Members. All ownership of the facilities and the operation thereof is vested solely in the City. Members have no ownership, property or equity right of any kind, and shall not have any responsibility or liability for the club's debts or operating expenses of any kind.
2. All committees, committee members, and their responsibilities shall be as specified by the City Council.
3. All advanced tee times are encouraged to be done online. **If a tee time is booked either online, in person or over the phone and must be canceled, it must be done in writing via email 24 hours prior to play (proshop@plantation.org).** The first infraction will result in a verbal/ written warning along with a cart fee charge. The second offense will result in suspension of the member's 7 day booking window.
4. Members may have their membership suspended or terminated at the sole discretion of club management for breach of club rules or for conduct detrimental to the Plantation Preserve Golf Course & Club standards. Members who have their membership terminated by club management will receive a prorated refund of membership dues.
5. Hours of operation of club facilities will be posted online seasonally.
6. No food, drinks or alcoholic beverages are allowed to be brought onto the club premises. Beverages will be allowed if it's part of a special event/tournament approved by the City or Guidant Management.
7. Except for special events, all Plantation Preserve Golf Course & Club facilities are for the use of club members and paying guests.
8. Bicycles, mopeds, private golf carts, etc. must be parked in designated areas and are not allowed on sidewalks or grass areas around clubhouse.
9. Permission must first be obtained from club Management for use of the Plantation Preserve Golf Course & Club grounds for group activities. This excludes the City of Plantation's Nature Trail.
10. Vandalism, theft or damage of City property or equipment caused by a Member, his family, or guests will result in the Member being financially responsible for all repair/replacement costs.
11. The member(s) agrees that the facility, the City, club management and club staff/employees shall be held harmless and bear no responsibility for the loss or damage to any personal property of the member, including but not limited to golf equipment, clothing or jewelry left in or on the premises of the club, including lockers, golf carts and golf club storage facilities. Any items stored on club property shall be at the sole discretion and sole risk of the member (s).
12. Plantation Preserve Golf Course & Club will not process refunds for memberships due to any force majeure events (such as a war, strike, riot, crime, epidemic, or an event described by the legal term Act of God.)

MEMBERSHIP RULES & INFORMATION

1. The Plantation Preserve Golf Course & Club membership year runs from October 1 through September 30.
2. New Members joining after October 1 will pay a prorated share of the annual membership fee. The prorated amount is determined by the value assigned to each month and varies seasonally.
3. All Members canceling their membership at any time will pay a \$100 administrative fee. Members canceling their membership after October 1 for medical (documentation required) or other reasons deemed valid by club management will receive a prorated refund. The prorated amount is determined by the value assigned to each month and varies seasonally.
4. All information supplied for the club roster is a public record, and while the City shall take steps to reasonably safeguard same, it makes no warranty or representation that it can keep any information placed thereon private or confidential.
5. A Member in good standing is entitled to only those privileges affiliated with their respective membership category.
6. A FAMILY membership allows the couple and all dependent children (or wards for whom the applicant is the legal guardian) under 24 years of age living in the same household use of the club facilities purchased.
7. Club memberships are not assignable or transferable to another individual/entity. To terminate membership prior to September 30, written notification must be submitted to the membership office, at least thirty days prior to termination.
8. Unsupervised Junior Members (under 18 years of age) should leave club property upon completion of their scheduled activity.
9. A Member may bring a maximum of 7 daily guests at any time pending approval from the Professional golf staff.
10. **Guests of Annual members will be given the Plantation resident rate. Guests of Seasonal members will be given the Florida resident rate.** Guests must be accompanied by a Member to receive the above rates.
11. Club Management, upon proper approval from the City, will retain the right to alter rules, increase fee schedules from time to time, decide on availability of facilities to various membership classifications and make all final decisions as to the operations of these facilities.

CLUBHOUSE RULES & INFORMATION

1. No one under the legal drinking age will be permitted to purchase or consume alcoholic beverages.
2. Children under 21 years of age must be accompanied by an adult when entering the club lounge after 5:00 pm.
3. The club reserves the right to deny service to any Member or guest at the Club's sole discretion.
4. There is a suggested dress code for the dining room, lounge area and clubhouse. We reserve the right to alter the dress code from time to time. Jackets are not required for dining, and cut-offs, frayed blue jeans, tank tops, short shorts and bathing attire are not allowed. Traditional golf attire is expected on the golf course, along with soft spikes.
5. Smoking is prohibited anywhere in the building.
6. Members may reserve clubhouse facilities for meetings or special functions upon request to club management. The room fee will be reduced to 50%.

GOLF RULES & INFORMATION

1. All players must personally register in the Golf Shop prior to play on the course. No one will be permitted to start on the 10th tee without authorization from the Pro Shop.
2. Greens fees will be charged for all guests. The same guest is only allowed to utilize the member guest rate 7 times in a calendar year.
3. If an annual or seasonal member fails to secure an advanced tee time they will enter the general portal will not be granted a "squeeze" time.
4. Golf Members may obtain tee times 7 days in advance. Seasonal members may obtain tee times 6 days in advance and the general public may obtain tee times 5 days in advance. Names of all players must be given.
5. In consideration of all our Members and guests, Members wishing to make a tee time for 9 holes must inform the golf shop at the time they book their tee time. The Golf Shop reserves the right to approve 9 hole tee times based on space availability and may start 9 hole players on either the 1st or 10th tee to best accommodate the tee sheet schedule for the day.
6. **Only one tee time will be allowed to be made from each member per day.** Players must register at least 10 minutes prior to play.
7. **If a member must cancel a tee time booked either online, in person or over the phone, it must be done in writing via email 24 hours prior to play (proshop@plantation.org).**
8. There is a posted dress code for the golf course. We reserve the right to alter the dress code from time to time.
 - Golfers will dress in a manner that is in keeping with the high standards of this club.
 - Proper shoes and golf shirts are required at all times.
 - Bathing attire, tank tops, halter tops, t-shirts, frayed cut-offs, uniforms other than golf (i.e. jogging, etc.) are not considered appropriate.
 - Medium and Bermuda length shorts with front pockets are permissible.
 - The golf staff will enforce the dress code. Individuals not dressed appropriately will not be allowed on the golf course play area
9. Golf Shop staff will issue a receipt to golfers to authorize play on the course and use of the golf cart. This slip **MUST** be presented to the Starter prior to play.
10. The Starter has the responsibility and authority to require twosomes to join together or place a single with a threesome. If a twosome is not willing to join another they will lose their assigned starting time and be required to accept a starting time following all foursome play. Five-some play is allowed at the discretion of the golf pro staff.
11. Each player is required to have a golf bag and set of clubs.
12. **Rain Check** – A Rain Check will be issued only when inclement weather (rain or lightning) makes the golf course unsafe or unplayable. A player scheduled to play 18 holes will be given a rain check for the full amount if they have completed less than 3 holes. 40% for completion of holes 4-12, and no rainchecks after hole #12. Requests for rain checks must be made the day of play. Rain checks will not be issued when the weather is threatening or rain is falling at the time of purchase of green fees and cart. Rainchecks will not be issued when teeing off after 4pm.
13. **Juniors:**
 - Approved Junior Golf Members may reserve starting times on the day of play, for play after noon Mondays thru Thursdays and after 3:00 pm Friday, Weekends and Holidays. Juniors may be allowed to play earlier at the discretion of the golf pro on duty.
 - Junior Play - Although junior play is encouraged, juniors under sixteen years of age must be accompanied by an adult unless their knowledge of etiquette and golf ability has been certified by the Club Professional or assistant. A class or lesson in golf play and etiquette may be required before such certification, and such certification may be revoked at any time.

14. The first 2 hours of tee times each day will prioritized by pace of play “faster groups have priority”. The first 2 hours of play are expected to maintain a pace of 3 hours and 45 minutes. Slow players with one or more “open holes” in front of them must move back into position to continue play. You will be asked to skip a hole if necessary.
15. Members may use the golf course for the purpose of playing golf. (No golf ball hawking, fishing, hunting, swimming, jogging, bike riding, dog walking, picnicking, etc.). Violators are subject to suspension of golf privileges.
16. Practicing golf shots is limited to the designated practice areas and not allowed on any hole or green on the course. Theft or use of Range Balls on the golf course will result in automatic suspension of golf privileges.
17. The Golf Course Superintendent is on the course to enforce the rules. It should be remembered that his/her recommendations and suggestions should be taken as affecting the benefit of all players. Failure to respond to the requests of the Superintendent may result in the loss of the privilege to play.
18. No one is allowed on the golf course or driving range when closed. Use of these facilities without authorization will result in issuance of trespass warrant &/or suspension of membership privileges
19. Tournaments and scheduled events will have priority over other play. Notice of these events will be posted in the Golf Shop and emailed. All tournaments are subject to a minimum \$2/player admin scoring fee.
20. Players who reserve starting times and “no-show” without proper cancellation notice may be denied advance tee times for future dates and may be charged for the unused tee time.
21. **Golf Carts:**
 - ♦ All Members and guests are required to rent carts.
 - ♦ The use of full carts at posted rates will be required at all times on the course.
 - Carts are rented to golfers who agree to operate them in a safe manner. The driver shall be held liable for any damage resulting from the operation of the cart. Only persons with valid driver’s license may operate full golf carts. Restricted licenses not accepted.
 - All carts must be kept at least 50 feet from tees and greens.
 - **No more than 2 individuals shall be allowed to ride in a golf cart at one time.**
 - No more than 2 golf bags shall be allowed in a cart.
 - When notified of wet conditions, all carts must be kept on cart paths - for the entire round.
 - Privately owned golf carts are prohibited.
